#### Cashing Checks

We would greatly appreciate it if you would cash your check within a couple of days after you receive your check.

If a check is not cashed within 6 months, the check will be voided and the money will go back into your account.

However, if you did not receive your check, let us know.

Your account will be current and stay updated when checks are cashed timely.

ACCOUNT BALANCE: All the information you need about your card and account history is available at www.paychekplus.com. You can check your balance and transactions and sign up for Text Alerts. This is all available online.

If you prefer to use the automated system, call the number on the back of your card. This number is 877-380-0978.

ALERTS: You can receive notifications by text or email, and Alerts can actually save you money. If you know your balance, you can avoid a Purchase Decline fee for trying to spend more money than you have on your card. Sign up for Text Alerts online or with customer service, and you can get your balance at any time by texting "BAL" to 90831. You can also set Alerts to notify you of other information - like when funds are loaded to your card account or when your balance goes below the amount you set. However, remember that text messaging rates will apply
